This appliance must be installed in accordance with the AS/NZS 5601.1 rules in force. PRIMARILY A DECORATIVE AND NOT HEATING APPLIANCE.

B. Glass Specifications

This appliance is equipped with ceramic glass. Replace glass only with ceramic glass. Please contact your dealer for replacement glass.

C. Gas Pressure Requirements

Pressure requirements for I25X-AU and I35X-AU fireplaces are shown in table below.

Two taps are provided on the gas control for a test gauge connection to measure the inlet and outlet pressures.

The fireplace and its individual shut-off valve must be disconnected from the gas supply piping system during any pressure testing of the system at test pressures in excess of 3.4 kPa.

If the fireplace must be isolated from the gas supply piping system by closing an individual shut-off valve, it must be of the handle-less type.

NOTE: An inline fuel pressure regulator is recommended to limit NG inlet pressure to 2.49 kPa, and LP/ULPG inlet pressure to 3.25 kPa, to ensure optimum product performance. The inline fuel pressure regulator may be needed if any of the following symptoms exist: pilot jetting, a highly visible pilot flame, flame variation, etc. The inline pressure regulator should be installed in the gas line upstream of the appliance gas valve either at the appliance or in the utility room. Final main and manifold gas pressure must be tested with inline pressure regulator installed.

D. High Altitude Installations

NOTICE: If the heating value of the gas has been reduced, these rules do not apply. Check with your local gas utility or authorities having jurisdiction.

When installing above 2000 ft. (610 m) elevation:

Reduce input rate 4% for each 1000 ft. (305 m) above 2000 ft. (610 m).

E. Non-Combustible Materials Specification

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750 °C (1382 °F) shall be considered non-combustible materials.

F. Combustible Materials Specification

Materials made of or surfaced with wood, compressed paper, plant fibers, plastics, or other material that can ignite and burn, whether flame proofed or not, or plastered or unplastered shall be considered combustible materials.

G. Electrical Codes

NOTICE: This appliance must be electrically wired and grounded in accordance with local codes or, in the absence of local codes, with AS/NZS 3000 latest edition.

2 Getting Started

A. Design and Installation Considerations

WARNING! Risk of Fire or Explosion! Read all instructions before starting the installation.

Gas inserts are designed for installations into solid fuel masonry or factory built fireplaces that have been installed in accordance with AS/NZS 2918 and the appropriate requirements of the relavent building codes. No additional outside air source is required.

Installation MUST comply with local, regional, state and national codes and regulations. Consult insurance carrier, local building inspector, fire officials or authorities having jurisdiction over restrictions, installation inspection and permits.

Prior to installing the gas insert:

- Ensure fireplace and chimney is constructed of noncombustible materials.
- · Ensure chimney is clean and in good working order.
- Ensure that all chimney cleanouts fit properly to prevent air leakage into chimney.
- Ensure combustible mantel and surround clearances comply with insert requirements.
- Ensure all joints are properly engaged and the chimney is properly secured.
- Determine minimum fireplace size. See Section 3.A and 3 B
- Determine gas supply piping requirements.
- · Determine electrical wiring requirements.
- Determine finishing details.
- Determine whether optional accessories—devices such as a wall switch or remote control—are desired.

Installation and service of this appliance should be performed by qualified personnel. Hearth & Home Technologies recommends HHT Factory Trained or NFI certified professionals.




Figure 2.1 Multi-Purpose Tool




Figure 2.2 Multi-Purpose Tool shipping Location




Figure 2.3 Multi-Purpose Tool Storage Options





Figure 2.4 Good Faith Wall Surface Temperatures Above Appliance

If installing a television (TV) above the appliance. See Figure 2.5

NOTICE: Temperatures listed above are taken with a temperature measuring probe as prescribed by the test standard used for appliance certification. Temperatures on walls or mantels taken with an infrared thermometer may yield increased temperatures of up to 30 °F (17 °C) or more depending on the thermometer settings and material characteristics being measured. Good Faith Guidelines for TV Installations above a Typical Gas Fireplace



Notes:

- 1. These are good faith recommended clearances only and not a guarantee of compliance with all TV manufacturers' maximum allowable operating temperatures.
- 2. Since every home has unique air flow characteristics and maximum allowable operating temperatures can vary from manufacturer to manufacturer and from model to model, actual TV temperatures should be validated at the time of each installation. TVs should not be used in situations where the actual TV temperature exceeds the manufacturers' maximum allowable operating temperatures identified in the TV's technical specifications. Contact the TV's manufacturer directly if you cannot locate this information or have questions regarding the information.
- 3. Mantel height and depth must conform to mantle requirements specified in the fireplace installation manual.
- 4. "C" dimension taken from the top of the hood or fireplace opening.
- 5. Suggestions on how to further reduce TV temperatures:
 - a. Increase "A" dimension.
 - b. Increase "C" dimension, however, increasing "B" dimension beyond maximum recommended typically results in higher temperatures.





B. Minimum Fireplace Opening

Minimum fireplace opening requirements for a standard 3/4 inch(19 mm) deep surround is shown in Figure 3.6. Unit opening size is the same for both standard surrounds.

WARNING! Risk of Fire or Burns! Provide adequate clearance around air openings and for service access. Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

For Installation into a Zero Clearance Wood burning fireplace:

- The brick (refractory), glass doors, screen rails, screen mesh and log grates can be removed from a factory built firebox in order to gain minimum gas insert opening requirements.
- Any smoke shelves, shields and baffles may be removed from the factory built firebox if attached with mechanical fasteners.




Figure 3.3 Solid Fuel Floor Clearance

• The appliance may not be placed directly on the base of the outer wrap, a 1/4 in. (6 mm) airspace <u>MUST</u> be provided between the insert and the floor of the outer wrap. Use the leveling legs to raise the insert a minimum of 1/4 in. (6 mm). The original fireplace may never be returned to solid fuel in this condition. The sidewalls and top structure of the firebox may not be altered with the exception of removable baffles and dampers.

- The metal floor of the solid fuel firebox may be removed to facilitate the installation of the insert.




Figure 3.4 Solid Fuel Firebox

- A metal lip protuding above the hearth pad of the solid fuel firebox may be removed. See Figure 3.4.

- Cutting of any sheet metal parts of the fireplace in which
 the gas fireplace insert is to be installed is prohibited,
 except the floor and front lip as tested for and as noted
 above. See Section 4.C for gas line exception.
- A minimum 1/4 inch gap from the bottom of the appliance to the metal floor of the solid fuel firebox is <u>REQUIRED</u>. See side view in Figure 3.3.
- Manufactured gas inserts can be installed as a zero clearance wall extension appliance. See Section 3C for clearance detail.





Figure 3.5 Minimum Required 1/2 in. (13 mm) Gap

C. Wall Extension

Surrounds MUST overlap wall extension.

A non-combustible wall extension can be used to cover an existing masonry surface. Wall extensions are typically used to improve cosmetics.

WARNING! Risk of Fire! Comply with all minimum clearances to combustibles as specified. Framing or finishing material closer than the minimums listed must be constructed entirely of noncombustible materials (i.e., steel studs, concrete board, etc).

Combustible facings must not extend behind the insert surround. See Sections 1.E and 1.F.

Non-Combustible Materials Specification

Material which will not ignite and burn. Such materials are those consisting entirely of steel, iron, brick, tile, concrete, slate, glass or plasters, or any combination thereof.

Materials that are reported as passing ASTM E 136, Standard Test Method for Behavior of Materials in a Vertical Tube Furnace at 750 °C.




Figure 3.7 Minimum Non-Combustible Framing Requirement




Figure 3.8 Non-Combustible Facing Requirement




Figure 3.9 Non-Combustible Framing / Facing Requirement

- Facing and/or finishing materials must not interfere with air flow through decorative fronts.
- Facing and/or finishing materials must never overhang into the glass opening.
- Observe all clearances when applying combustible materials.
- Maximum depth of wall extension is 12 in. (305 mm).
 This may be limited by the flex pipe's ability to connect to the starting collar.
- Covering combustible materials with non-combustible materials does not qualify material as non-combustible.

WARNING! Risk of Fire! DO NOT apply combustible materials beyond the minimum clearances. Comply with all minimum clearances to combustibles as specified in this manual. Overlapping materials could ignite and will interfere with proper operation of decorative fronts.




Figure 3.10 Transition Sealing Detail for Wall Extensions (Side View)

Wall Extension

Wall extension must be sealed to existing masonry wall. See Figure 3.10. Framing studs may not sit flush against existing masonry wall. In order to keep heat from escaping behind the wall this transition must be sealed.

Seal with a high temperature silicone 300 °F (149 °C).

and / or

 Packing insulation into voids between the masonry wall and steel studs is acceptable.

Note: Combustible materials may be used to seal wall extension to existing masonry wall as long as it is outside the non-combustible zone.

Painting

If desired finishing includes a painted wall, a high-quality 100% acrylic latex paint with a high-quality latex primer base coat are recommended around the appliance to limit discoloration. Oil-based or standard acrylic paints may be more prone to discoloration due to heat exposure.

Drywall Joint-Crack Prevention and Repair

Drywall joints around the fireplace will be affected by exposure to elevated temperatures, along with other environmental, structural factors due to new construction, and methods used to install and finish the drywall. If a crack does emerge adjacent to the fireplace, it can be permanently repaired by filling it with a paintable latex caulk, followed by repainting.

Some movement of the screws used to secure the noncombustible board to the appliance/surround framing is expected. If a blemish begins to show over a screw head, sand the surface to remove the blemish and repaint.

NOTE: Concealed sections of 3 in. flex pipe must be contained inside existing masonary fireplace flue vent or installed into an existing wood burning vent system.

D. Mantel, Wall Projections, & Hearth Extensions

WARNING! Risk of Fire! Comply with all minimum clearances to combustibles as specified. Framing or finishing material closer than the minimums listed must be constructed entirely of noncombustible materials (i.e., steel studs, concrete board, etc).

Clearance to combustible material under the insert is 1/4 inch (6 mm).

Use leveling legs to raise insert minimum 1/4 inch (6 mm) above combustible material or outer wrap of factory built firebox.

Combustible facings must not extend behind the insert surround. For non-combustible material specifications refer to Section 1.E and 1.F.




Figure 3.11 Clearances to Mantel Legs or Wall Projections (Acceptable on both sides of surround opening)




Figure 3.12 Minimum Vertical and Maximum Horizontal Dimensions- Non-Combustible




Figure 3.13 Minimum Vertical and Maximum Horizontal Dimensions - Combustible




Figure 3.14 Minimum Required 1/2 in. (13 mm) Gap to Bottom of Front

- 1/2 in. (13 mm) gap under the bottom of the front must be maintained. See Figure 3.14.
- A minimum 1/4 in. (6 mm) gap from the bottom of the appliance to any floor surface is <u>REQUIRED</u>. See side view in Figure 3.17.
- Combustible flooring underneath the appliance is acceptable with a 1/4 inch 6 mm) gap. See Figure 3.17.




Figure 3.15 Combustible Material Exception




Figure 3.16 Hearth - Minimum Height for Vinyl / Adhesive or Carpeting Flooring




Figure 3.17 Solid Fuel Floor Clearance




Figure 3.18 Flooring & Hearth Material

Installation Preparation

Prepare the existing solid fuel masonry or factory built non-combustible firebox for installation.

A. Cleaning

Prior to installing the gas insert:

• Ensure that the woodburning fireplace cavity is clean and free of ash, soot, and other debris.

B. Flue Damper

Fully lock the solid fuel fireplace's flue damper in the open position, OR completely remove it.

C. Gas Line

Note: If the factory built fireplace has no gas access hole provided, an access hole of 1 inch (25 mm) diameter or less may be drilled through the lower sides or bottom of the firebox in a proper workmanship - like manner. This access hole must be plugged with non-combustible insulation after the gas supply line has been installed.

- If the gas access hole of the factory-built fireplace is not accessible or prohibits the installation due to its location, an access hole may be drilled through the lower side, back or bottom of firebox.
- The lower sides, back, or bottom is considered the lower half of the factory-built firebox.
- Install gas line to the factory provided flex line. See Figure 4.1.
- Check local codes and gas line sizing requirements following AS/NZS 5601. See Section 7.
- It is recommended that extra length of gas line be installed within the existing wood burner or masonry fireplace to allow removal of the insert for future servicing needs.

D. Fireplace Conversion Notice

The fireplace conversion notice is included in the appliance manual bag. Permanently attach the label with the following warning to the inside lower back of the fireplace firebox into which the insert is being installed. Silicone or mechanical fasteners may be required to properly secure the label.

WARNING! Risk of Fire! This fireplace has been converted for use with a gas fireplace insert only and cannot be used for burning wood or solid fuels unless all original parts have been replaced, and the fireplace re-approved by the authority having jurisdiction.

E. Electrical Outlet Box

An outlet box may be installed in a bottom back corner of the existing solid fuel masonry or factory built fireplace to power the appliance. Each unit ships standard with a cord assembly to permit blowers or other optional accessories to be used. The accessories plug into the new outlet box or may be routed out onto the hearth to a nearby outlet.

NOTICE: DO NOT wire 220/240 VAC to wall switch.




Figure 4.2 Electrical Outlet Detail








Figure 5.2 Min. / Max. Venting Requirement




Figure 5.3 Firebox Baffle

C. Venting Components



D. Connecting to SLP




Figure 5.5 Optional SLP Venting Configuration - Vertical Termination

E. Connecting Vent Pipe

Reference instructions in the termination kit.

- Install the 3 in. (76 mm) flexible vent pipe(s) down through the chimney.
- Secure the exhaust flexible vent pipe to the exhaust starting collar on top of the appliance with three screws. See Figure 5.1.
- Use 3 screws to attach the section of inlet air vent to the inlet collar on the collar slide plate. See Figure 5.1.
 NOTE: The collar slide plate may be removed from appliance to aid installation and service.

For best results in cold climate be sure 3 in. (76 mm) flex is flush and tight to the collar slide plate. Seal with stove cement or aluminum foil tape. Do not use silicone.



- Trim chimney top plate to minimize excess overhang or bend over flue tile. See Figure 5.6.
- Place 3/8 in. (10 mm) bead of 300 °F (149 °C minimum continuous exposure rating) silicone on flue tile top.

F. Placing, Securing and Leveling the Appliance

WARNING! Risk of Explosion/Combustion Fumes! Connect vent sections per installation instructions.

- Connect exhaust vent pipe ONLY to exhaust starting collar and termination cap center collar.
- Connect inlet air vent ONLY to inlet air collar on appliance and either the termination cap inlet air collar.
- DO NOT allow vent to sag below connection point to appliance.
- Install insert (without surround attached) into existing fireplace while pulling collar slide plate forward.




Figure 5.7 Leveling Leg Detail

- Install gas line into hole provided on side. See Figure 5.7.
- Secure collar slide plate to appliance by securing with #8 screw. See Figure 5.1.
- Level the appliance from side to side and front to back.
 Adjust leveling bolts to desired vertical position so appliance is level. Use the leveling bolts included with the manual bag.
- Position any excess flexible vent pipe back up into chimney without sagging. Twist and push flex vent together to shorten.
- Attach surround. Follow instructions for surround installation included with the front.
- Push insert into the opening so that it tightly overlaps the fireplace opening.




Figure 5.8 Minimum Height from Roof to Lowest Discharge Opening




Figure 6.1 Electrical Outlet Detail




Figure 6.2 IntelliFire™ Plus Wiring Diagram with Remote

Battery Pack

Battery pack is not factory installed in appliances. See appliance manual bag for battery pack. Battery pack should only be installed during power outages.

NOTICE: Batteries should only be used as a power source in the event of an emergency power outage. Batteries should not be used as a primary long-term power source. Battery polarity must be correct when installing batteries.

Do not store batteries in the battery pack when the appliance is powered by the 6 volt transformer connected to permanent electrical service. Store battery pack in appliance manual bag when not in use.

C. Installation / Service for Fan

On units already installed, removal of decorative front and gas insert may be required.




Figure 6.3 Cover Plate Removed (Option 1)




Figure 6.4 Through Valve Plate Opening (Option 2)




Figure 6.5 Cover Plate Removal (Option 1)




Figure 6.6 Through Valve Plate Opening (Option 2)




Figure 6.7 Gas Valve Detail




Figure 7.1 Gas Shut-off




Figure 7.2 Glass Clip Assembly Removal




Figure 7.3 Component Tray - I35X-AU

B. Gas Pressure

WARNING! Risk of Explosion! An in-line regulator MUST be installed if the gas pressure exceeds 3.4 kPa. Failure to install a regulator could damage valve.

Pressure requirements for fireplaces are shown in the table below.

Two taps are provided on the right hand side of the gas control for a test gauge connection to measure the inlet and outlet pressures.

The fireplace and its individual shut-off valve must be disconnected from the gas supply piping system during any pressure testing of the system at test pressures in excess of 6 kPa.

If the fireplace must be isolated from the gas supply piping system by closing an individual shut-off valve, it must be of the handle-less type.

- Optimum appliance performance requires proper input pressures.
- · Pressure requirements are:

- Verify inlet pressures. Verify minimum pressures when other household gas appliances are operating.
- Install regulator upstream of valve if line pressure is greater than 3.40 KPa.

- Disconnect gas supply piping BEFORE pressure testing gas line at test pressures above 3.40 KPa (1/2 psig).

C. Gas Service Access

Note: This appliance does include a manual gas shutoff valve that is located in the valve compartment. This manual gas shutoff valve is accessible for service by removing the decorative front. The valve is most accessible if it is located forward in the control cavity of the appliance.

Depending upon local code, an additional manual gas shutoff, in a readily accessible area may be required and located upstream from the appliance.

D. Gas Connection

- · Refer to Reference Section 3 for location of gas line.
- The gap between supply piping and gas access hole may be caulked with caulk with a minimum of 300 °F (149 °C) continuous exposure rating or stuffed with non-combustible, unfaced insulation to prevent cold air infiltration.
- Ensure that gas line does not come in contact with outer wrap of the appliance. Follow local codes.
- Pipe incoming gas line to the factory supplied flex line.
 See Figure 7.4.
- Connect incoming gas line to the 1/2 in. (13 mm) connection on manual shutoff valve.

WARNING! Risk of Fire or Explosion! Support control when attaching pipe to prevent bending gas line.

· A small amount of air will be in the gas supply lines.

WARNING! Risk of Fire or Explosion! Gas build-up during line purge could ignite.

- Purge should be performed by qualified service technician.
- Ensure adequate ventilation.
- Ensure there are no ignition sources such as sparks or open flames.

Light the appliance. It will take a short time for air to purge from lines. When purging is complete the appliance will light and operate normally.

F. Air Shutter Setting




Figure 7.5 Air Shutter

Air shutter settings should be adjusted by a qualified service technician at the time of installation. The air shutter is set at the factory for minimum vertical vent run. Adjusting air shutter may be desired for longer vent runs. See Figure 7.5.

8 Finishing

A. Mantel, Wall Projections, & Hearth Extensions

WARNING! Risk of Fire! Comply with all minimum clearances to combustibles as specified. Framing or finishing material closer than the minimums listed must be constructed entirely of noncombustible materials (i.e., steel studs, concrete board, etc).

Clearance to combustible material under the insert is 1/4 inch (6 mm).




Figure 8.1 Clearances to Mantel Legs or Wall Projections (Acceptable on both sides of surround opening)




Figure 8.2 Minimum Vertical and Maximum Horizontal Dimensions- Non-Combustible




Figure 8.3 Minimum Vertical and Maximum Horizontal Dimensions - Combustible




Figure 8.4 Minimum Required 1/2 in. (13 mm) Gap to Bottom of Front




Figure 8.5 Combustible Material Exception




Figure 8.6 Hearth - Minimum Height for Vinyl / Adhesive or Carpeting Flooring




Figure 8.7 Solid Fuel Floor Clearance




Figure 8.8 Flooring & Hearth Material

9 Appliance Setup

A. Fixed Glass Assembly

WARNING! Risk of Asphyxiation! Handle fixed glass assembly with care. Inspect the gasket to ensure it is undamaged and inspect the glass for cracks, chips or scratches.

- DO NOT strike, slam or scratch glass.
- **DO NOT** operate fireplace with glass removed, cracked, broken or scratched.
- · Replace as a complete assembly.

CAUTION! Handle fixed glass assembly with care. Glass is breakable.

- · Avoid striking, scratching or slamming glass
- · Avoid abrasive cleaners
- DO NOT clean glass while it is hot
- The glass assembly fastens to the fireplace in four places. Four of the fastening mechanisms are springloaded glass latches. An example of the glass latch is shown in Figure 9.2.
- To release glass assembly, use the supplied multipurpose tool to pull the two bottom spring-loaded latches forward and allow them to retract away from the glass assembly. Tilt the bottom of the glass assembly outward until the top latches disengage.




Figure 9.1 Multi-PurposeTool

Replacing Fixed Glass Assembly

- Tilt the top of the glass assembly toward fireplace and slide glass assembly upward to engage top latches. Verify top latches are fully engaged and then fasten the two bottom latches using the supplied multi-purpose tool.
- · Reinstall door or decorative front.




Figure 9.2 Glass Seal Plate and Glass Latch

WARNING! Glass seal plate must be properly installed. Risk of elevated component temps and carbon monoxide exposure.

B. Remove the Shipping Materials

Remove shipping materials from inside or underneath the firebox.

Note: Remove the zip ties from the appliance that hold the electrical cord, gas flexline and multi-purpose tool in place for shipping.

C. Clean the Appliance

Clean/vacuum any sawdust that may have accumulated inside the firebox or underneath in the control cavity.

D. Accessories

Install approved accessories per instructions included with accessories. Contact your dealer for a list of approved accessories.

WARNING! Risk of Fire and Electric Shock! Use ONLY Hearth & Home Technologies approved optional accessories with this appliance. Using non-listed accessories could result in a safety hazard and will void the warranty.

E. Mystic Embers Placement

WARNING! Risk of Explosion! Follow mystic ember placement instructions. **DO NOT** place mystic embers on burner. Improperly placed mystic embers interferes with proper burner operation.

Mystic embers are shipped with this gas appliance. To place the embers:

- Mystic embers CANNOT be placed on the burner.
- Place mystic embers in front of and to the sides of the burner.

F. Glowing Ember Placement

WARNING! Risk of Explosion! Follow ember placement instructions in manual. Replace ember material annually. Improperly placed embers interfere with proper burner operation.

Glowing ember material is shipped with this gas appliance. To place the ember material:




Figure 9.3 Placement of Embers

- Embers CANNOT be placed in the shaded area as shown in Figure 9.3.
- Glowing embers must be placed loosely over the port holes, not pressed down on or into the holes. Create a single layer, no more than 1/4 inch thick.
- Failure to follow this procedure will likely cause lighting and sooting problems.
- Save the remaining ember materials for use during appliance servicing. The embers provided should be enough for 3 to 5 applications.

G. Reverse Drafting

If the appliance is operated with the glass assembly removed during setup, reverse drafting may occur. If reverse drafting continues with the glass assembly installed, turn off appliance and allow appliance to cool with glass off.




Figure 2. Empty Firebox with Front Hearth Installed




Figure 3. Log #1 Installed

LOG #1: Locate the cutout on Log #1, place it over the pilot hood and set the log on the left side of the firebox. Rotate Log #1 clockwise until it contacts log pin A and the firebox wall. Ensure that the end of Log #1 is in contact with the air scoop. See Figure 3.




Figure 4. Log #2 Installed

LOG #2: Set Log #2 on the burner between pins B and C. Rotate the log counter clockwise until it contacts both pins B and C and slide it back until it contacts the Air Scoop. Ensure Log #2 is not covering any ports. See Figure 4.




Figure 5. Log #3 Installed

LOG #3: With the burnout of Log #3 facing left, line the big end up with the edge of the basepan and the firebox wall or refractory. The small end will sit half on the end of Log #2 and half on the air scoop as shown in Figure 5.




Figure 6. Log #4 Installed

LOG #4: The Y-end of Log #4 should sit on the flat spot of Log #2, the other end will sit on the flat spot of Log #1. See Figure 6




Figure 7. Log #5 Installed

LOG #5: Place the non-bark end of log 5 on the flat spot of log 3. The front right corner on the other end of log 5 will sit at the intersection of the grout lines on the base refractory. See Figure 7.




Figure 9 Empty Firebox with Front Hearth Installed




Figure 10. Log #1 Installed

LOG #1: Locate the cutout on the end of Log #1. The other end of Log #1 will set between log pins A and B. Rotate the cut-out end back until the cut-out fully engages the air scoop. See Figure 10.




Figure 11. Log #2 Installed

LOG #2: The short side of the Y on Log #2 will sit between log pins D and E, the long end of the Y will sit against log pin C. The opposite end of Log #2 will sit on the air scoop. See Figure 11.




Figure 12. Log #3 Installed

LOG #3: With the burnout facing left, place the big end of Log #3 against log pin F and slide back until it contacts log pin G as shown in Figure 12. The small end will sit on the flat spot of Log #2.




Figure 13. Log #4 Installed

LOG #4: Set the non-Y end of log 4 on the flat spot of Log #1. The end of Log #4 will sit flush with the back of Log #1. The Y-end of Log #4 will sit on the flat spot of Log #2. See Figure 13.




Figure 14. Log #5 Installed

LOG #5: The non-burnout end of Log #5 will sit on the flat spot of Log #3. The other end will sit against the edge of the base refractory grout line. See Figure 14.




Figure 16. Log #6 Installed

LOG #6: Slide the burn out end of Log #6 between log #5 and log #3. Push the log back until it touches the firebox. The left side will touch pin H. The right side of the log touches Log #3. See Figures 15 and 16.

I. Install Decorative Front and Surround

A decorative front and surround is required to complete this installation. Installation instructions are included with the decorative front and surround. Consult your dealer for a list of decorative front and surround options.




Figure 9.4 Surround Reset Switch




Figure 9.5 Required 1/2 in. (13 mm) Gap




Figure 10.1 Direct Vent Flex Liner Kit




Figure 10.2 Direct Vent Flex Liner Accessory Kits
